This warranty is extended only to the original end-use purchaser or the person receiving the product as a gift, and shall not be extended to any other person or transferee.

Unless a different warranty period is otherwise stated for a particular model in the installation instruction or owner's guide provided with your purchase, for a period of 1 (one) year from the date of retail purchase by the original end-use purchaser, e-dustry, inc. (hereinafter referred to as the "Company") warrants that this product, when delivered to you in new condition, in original packaging, purchased either online directly from the Company, or from a Company's authorized reseller and used in normal conditions, is free from any defects in manufacturing, materials and workmanship.
